Committee Reports

- Code Enforcement Committee: Mrs. Caldarelli reported that citations have been issued against 31 landlords for not registering 34 rental properties as part of the 2016-17 Rental Registration Program.
 She also stated that the current operations of Code Enforcement have been working well with both the Firefighters and Office Staff handling code related complaints.
- Public Safety: Mrs. Drewnowski reported that the Public Safety Committee met on December 8,
 2016, present included: Chief Mann, Chief Gottschalk, Mr. McCoy, Mr. Dunn, Mayor D'Ambrosio,
 and herself. She reported that in regards to the Police Department:

- (a) There have been over 70 Heroin overdoses so far this year in the Borough.
- (b) There has been a rash of cars broken into, but the Police Department has identified the person responsible and a warrant is out for his arrest, and;
- (c) Chief Mann reminded everyone that this is the time of year that purse snatchings, vehicle break-ins and bank robberies occur most. He asked everyone to please be aware of your surroundings and to report any suspicious activity to the Police.

Mrs. Drewnowski reported that in regards to the Fire Department:

- The AFD has received a \$1,200 Fire Prevention Grant from FM Global Insurance Company. This brings the total grants received this year to four with a total of \$30,000 received.
- Public Works: Mr. Cafarelli reported on the following:
 - Curbside Leaf Collection concluded December 9th, leaves and yard waste will now have to be bagged for pickup.
 - The new roof on the Borough Building has been completed, inspected by the architect, and 20-year warranty paperwork is on file in the Manager's office.
 - Crew put up Christmas decorations and decorated the Borough Building, PJ Caul Park, Merchant Street between 4th and 8th Streets, Merchant Street in the Historic District and the small parklet next to the Magistrates office.
 - Ongoing maintenance has been dedicated to filling pot-holes and repairs to alleys.
 - Equipment Maintenance:
 - o A new battery has been installed in the street-sweeper. The sweeper has been winterized and is now stored in the fire station for the winter months.
 - Chevy Colorado Pickup has been inspected and oil changed.
 - Sign maintenance is on-going, replacing missing signs and repairing damaged locations.
 - Foreman responded, marked and reported multiple PA-One Call requests.
- Parks: No report.
- Engineer's Report: Engineer Suehr reported that he has recently completed the plans for the 2017 Road Program. He stated that he will have copies of the plans for the Road Committee to review. The Engineer also reported that he has received a proposal for \$3,100 to complete core sampling to finalize the 2017 Road Program project specifications. Mr. Suehr updated Council on the needed storm water outfall repairs under the Ambridge-Aliquippa Bridge; he stated that it remains unchanged. He also reported that the repairs to the 8th and Maplewood catch-basin project and the Borough Building Roof Replacement Project are both complete. He updated Council that he reviewed some settling behind 959 Hazel Avenue this past month and that he provided the Manager with Merchant Street maps for the upcoming Streetscape Project. Lastly, he thanked the members of Council who attended their annual Christmas Party.

Mr. Mikulich stated that the Borough has received six bids for the design of the Merchant Street Streetscape Project. He stated that action will be taken at the January Meeting to award contract.
