- The February 13, 2018 meeting of Ambridge Borough Council was called to order at 7:00PM within Council Chambers of the Ambridge Borough Building, 600 11th Street.

- Invocation the invocation was conducted by Mrs. Barbara Costa, Trinity School for Ministry.
- Pledge of Allegiance
- Presentations Borough Council and Mayor presented a proclamation to Bob and Denise Dunn for their annual Christmas display and efforts that supported St. Jude's Children's Research Hospital.
- Citizen's Participation On/Off Agenda Items (5 minutes per speaker)
 - 1. **Mr. Tom Friend, 511 Merchant Street,** questioned Council regarding the trailers parked on Duss Avenue by Creekside Springs Water Company that he made complaint about last month. He is concerned that the trailers pose a danger to motorists at night and should have reflectors on them.
 - 2. **Ms. Lillian Peaff, 1325 N. Walnut Street,** expressed concerns to Council about dog owners not picking up after their dogs while out on walks. She stated that there is an issue with dog waste in the planting strip in the area of 15th Street and Lenz Avenue. She suggested that the planting strip be removed to take away the area for the dogs to do their business. Mr. Mikulich informed her that it is a crime to not pick up after your pets. She was encouraged to call the police if she witnesses this matter in the act in the future.
 - 3. Mr. Fred Alexander, 401 Merchant Street Solicitor Start informed Mr. Alexander before he spoke, that his comments regard a matter that is part of ongoing litigation and that the Council is aware of his issue and will not make any comments relative to it tonight. Mr. Alexander read portions of an already prepared letter that summarized an issue he has with the Borough's Rental Property Registration Program and property he owns at 401 Merchant Street. He stated that he received multiple notices from Code Enforcement to register the property, he provided a letter to the Borough in 2017 stating that the building is under construction and not rental property but did not allow the code officers into the structure to verify. He stated that he was then cited for failing to

comply with rental registration and was fined by the District Court. He then met his five minutes for public comment and was asked to stop by Mr. Mikulich.

- 4. **Mrs. Non Alexander, wife of Fred Alexander, 401 Merchant Street,** stated that they do a nice job fixing up properties in town. Stated they are good people, who do all of the work themselves and haven't done a bad job so far.
- 5. **Mr. Stanley Williams, 70 15th Street**, informed Council that the owner of the Harmonist House at 13th Street and Church Street is making significant improvements to this building. He stated that he hopes to have the work done within six months.
- 6. **Mr. Mike Rogers, 424 Merchant Street, Apt. 8**, stated that the intersection of 4th Street and Route 65 should be a No Turn on Red intersection to prevent accidents. He also stated that the No Parking signs in the Upper Alley need to be replaced as they are not legible. Mr. Mikulich informed Mr. Rogers that we will update the signage. Mr. Rogers also stated that he has heard noises coming from 420 Merchant Street and believes parts of the building have collapsed. Chief Gottschalk informed him that the property owner has been cited for the rodent and property maintenance issues relative to 420 Merchant Street. The hearing is tomorrow.

Committee Reports

- Code Enforcement Committee: No report.
- Public Safety: Mr. Flannery reported that he has met with both the Police and Fire Chiefs this past month; a Committee Meeting will be forthcoming.
- Public Works: Mr. Cafarelli reported that the committee met on January 19th, present was himself. Mr. Flannery, Manager Kauer, DPW Foreman Eberhardt, and Mayor Drewnowski.

Meeting Highlights

- Discussed Ice Storm that occurred January 14 and 15, came up with ways to mitigate ice storms in the future if similar conditions occur
- Problems with the Ice Storm were that a significant amount of ice accumulated before it transferred to snow.
- Temperatures were too low for salt to be affective. Salt is not as efficient under 20 degrees
- Rubber snow plow blades were not as effective clearing the ice.
- Expressed concerns with PENNDOT for snow removal on Rt. 989
- Agreed to purchase an emergency supply of Cinders to use in intersections if road-salt is not performing or effective.
- Agreed to purchase one steel snow-plow cutting bar to be set up and used on the newer streets if the rubber blades do not work in the future.
- Drafted and put out a press release on DPW Snow Operations, explaining how snow removal takes place in the Borough. This information was released the third week of January and is also still posted on the Borough website, www.AmbridgeBoro.org
- Made communication with PENNDOT regarding snow removal on Rt. 989.

Mr. Cafarelli also reported the following highlights from the Public Works Department:

- Crew has been busy with snow removal of streets and public sidewalks
- Emergency supply of cinders has been received should conditions occur when salt isn't that effective.
- Crew took down and put away all of the Christmas decorations from the Borough Building, Merchant Street and PJ Caul Park.
- Cleaned catch basins on January 12th throughout town.
- Equipment Maintenance:
 - Red Ford F-550 Dump Truck Power Steering Line was fixed, truck was inspected and oil was changed.
 - Ford F-350 Pickup Truck Front brakes were replaced, truck was inspected and oil was changed.
 - Flatbed conversion kit for Ford F-350 Pickup Truck was ordered, crew will switch out beds in-house in the spring.
- Sign maintenance is on-going, replacing missing signs and repairing damaged locations.
- Loading Zone Sign at Maple Restaurant was put in on January 22nd.
- Bank Street No Parking Signs have been installed MoreFlavor has been billed for the sign work and for the costs associated with the Ordinance.
- Rt. 989 Truck Sign Route Signs have been improved by DPW, signs are posted at all locations directing trucks to northern Duss Avenue
- Crew is refurbishing the old German Street Name Signs for Church Street within the Historic District.

- Ongoing maintenance has been dedicated to filling pot-holes and repairs to multiple alleys.
- Foreman responded, marked and reported multiple PA-One Call requests.

Mr. Cafarelli requested that a letter be sent from the Borough to Representative Matzie and Senator Vogel to direct PENNDOT to install over-head signage on 8th Street to mark the new turning lanes onto Route 65.

Mayor Drewnowski thanked Mr. Cafarelli for inviting him to attend the recent Public Works Committee Meeting. Mr. Mikulich stated that our Public Works crew does a great job, he has concerns about the long hours they work during severe snow storms.

- Parks: Mayor Drewnowski stated that he attended the last Parks and Recreation Committee Meeting. He stated that Mrs. Miller does a lot of work as part of this committee. He stated that she is always trying to get the best price on the best products for the town. The Mayor stated that at the last meeting, work has been focused on designing the improvements to be made at Panek Park and 8th Street Park this year.
- Engineer's Report: Engineer Suehr stated that he attended the last Parks and Recreation Committee
 Meeting and is currently working on development project specifications and bid documents for the
 Parks Improvement Project. He also reported that he is working with Hancock Architecture with the
 application to PENNDOT for a Highway Occupancy Permit that is needed at 8th Street for the
 Streetscape Project.
