Mr. Mark Crano, 817 Beaver Road, requested that Ambridge residents have first option to purchase bonds as part of the Borough's 2016 Bond Issue. Solicitor Start advised Mr. Crano that the Borough will advise our underwriter of this request.

Ms. Lorianne Burgess, 570 Merchant Street, questioned the status of the Ambridge Police Sub-Station that is located within the Chamber of Commerce Building on Merchant Street. She stated that the police seldom use this building and if they used it more, the increased police presence would have a positive impact at reducing crime on Merchant Street. President Mikulich advised her that the building will remain a police sub-station even with the new lease with the Ambridge Regional Chamber of Commerce. He also advised her that her concerns will be shared with the Mayor and Chief of Police to see if they would occupy this office more.

Mr. Cafarelli questioned that after they occupy the building, will it serve as a Visitor's Center and Police Sub-Station? President Mikulich confirmed that it will stay as those uses.

- Motion to authorize the 2016 Bond Issuance in the amount of \$2,790,000.00 with the following preliminary budget:
 - (a) \$100,000 Borough Building Roof Replacement
 - (b) \$600,000 New Fire Engine replacing the 1973 American LaFrance Snorkel
 - (c) \$90,000 Backhoe for Public Works Department
 - (d) \$1,000,000 Merchant Street Streetscape Project
 - (e) \$1,000,000 Road Resurfacing and Reconstruction throughout the Borough

President Mikulich stated that should the recently submitted FEMA Grant for a new fire engine be approved, those funds will be repurposed for additional road resurfacing work. Mrs. Drewnowski stated that borrowing funds is at an all-time low right now. She stated that these projects identified would probably be the same projects financed 3-4 years out, should we have paid the debt all off in 2018. It was her recommendation to borrow the funding now while interest rates are much lower than what is projected four years from now.

Mr. Cafarelli questioned the length of the bond issue; he was advised by President Mikulich that we are planning on this to be a 10 year bond issue. Mr. Mikulich also stated that this bond issue had to happen in order to restructure the Borough's debt. If we do not do anything, the annual debt payments are close to \$600,000 and would cause the Borough to continue to operate with a deficit. He thanked Mrs. Drewnowski and the Borough Manager for their efforts to bring about this bond issue consideration.

- Discussion Kennedy Drive: Consider making Kennedy Drive between 10th and 11th Street, one-way in a northbound direction. Mr. Mikulich stated that multiple residents and business owners have expressed concerns to him about the adverse effects that the traffic has had on them and requested the Borough consider redirecting the traffic elsewhere. It was decided to direct the Public Safety Committee to discuss and study this matter at its next meeting. Mr. Cafarelli suggested that the Committee also consider, if this moves forward, that a prohibition of No Left Turn onto 11th Street from Kennedy Drive be implemented. Mrs. Drewnowski requested the Borough Manager to survey the Kennedy Drive residents in advance of the February 3, 2016 Public Safety Committee Meeting. She also requested both the Police and Fire Departments to review this proposal in advance of the Public Safety Committee Meeting.
- Motion to hire Mr. Cody Wisenor as a probationary part-time police officer, effective January 13, 2016. Motion was made by Mrs. Drewnowski, seconded by Mr. Dunn; a roll call vote was taken:

Mr. Mikulich stated that this hire is as result of three current part-time police officers finding employment elsewhere. He stated that this hire will replace all three that left.

Committee Reports

- Administration and Finance: Mr. Mikulich stated that there is no Administration and Finance Committee in 2016. He stated that all members of Council are responsible for this Committee and its responsibilities moving forward. He also reported that \$330,000 was recently transferred from the Borough's Sinking Fund to our General Fund, basically serving as a 0% interest Tax Anticipation Loan for the Borough until early March. This fund transfer will help sustain operations until real estate taxes are received for the year.
- Code Enforcement Committee: No Report
- Public Safety: Mrs. Drewnowski stated that the Fire Department submitted a grant to FEMA seeking \$698,000 to purchase a new fire engine that would replace a fire engine of ours that is 43 years old. She stated the requests for project endorsement have been sent to Congressman Rothfus and Senators Casey and Toomey. She thanked Assistant Chief Gottschalk and Firefighter Larrick for their efforts to prepare this grant application.

Mrs. Drewnowski also reported that on January 9th, it was National Law Enforcement Appreciation Day. She encouraged everyone to say hello and thank our officer for their service when you see them.

- Public Works: Mr. Cafarelli reported on the following items regarding the Public Works Department:
 - Collection of Christmas Trees is ongoing through February 1st. Trees can also be dropped off at the Public Works Facility during the weekends.
 - Trucks are ready for winter operations first winter call-out for snow / ice removal was on January 3rd.
 - Hydraulic repairs were made to the F-650 Dump Truck on January 6 at Diamondhead.
 - Ongoing maintenance has been dedicated to filling pot-holes.
 - DPW Crew is currently making extra traffic horses.
 - Sign maintenance is on-going, replacing missing signs and repairing damaged locations.

- Foreman responded, marked and reported multiple PA-One Call requests.
- Parks: No report.
- Engineer's Report: Engineer Suehr reported that he is working on calculating the costs to reconstruct / repave the proposed roads that have been suggested for the 2016 Bond Issue. Council suggested to the Engineer to add brick repairs on Maplewood Avenue between 11th and 12th Streets and also on 8th Street between Beaver Road and Pine Street.

Mr. Mikulich congratulated Mr. Suehr on recently passing the state's Professional Engineer's certification exam.
