As of today's date the Police Department still has one officer off on workers compensation and is due back November 1, 2020. We also had a part-time officer resign for full-time employment elsewhere. We are now down to 18 officers.

The in-car camera systems are running smoothly, and all officers that are assigned to these cruisers are using them well.

The Borough Manager and I are finalizing the grant application for the body worn cameras and will submit it before the deadline of October 15, 2020.

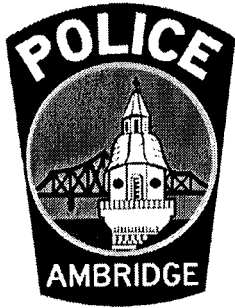

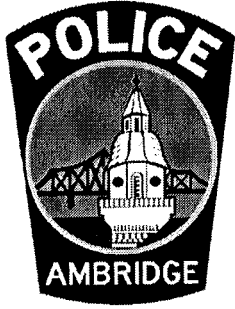

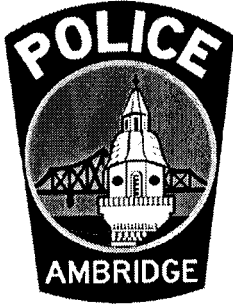
