Attached you will find the monthly lists of all reports submitted by the Ambridge Police Department for the month of September 2020. All privacy information has been redacted.

As of today's, date the Police Department still has one officer off on workers compensation and is due back November 1, 2020. We also had a part-time officer resign for full-time employment elsewhere. We are now down to 18 officers.

The in-car camera systems are running smoothly, and all officers that are assigned to these cruisers are using them well.

The Borough Manager and I are finalizing the grant application for the body worn cameras and will submit it before the deadline of October 15, 2020.

The Police Department is up and running with carrying Naloxone in the cruisers every shift and has deployed it twice both outcomes were life saving reversals from overdose. I would like to take some time at the meeting to serve letters of commendation to the officers that deployed Naloxone to save two lives here in the Borough of Ambridge.

The Police Department has actively been performing traffic details throughout the Borough. Please see attached statistics on the next page.

As of this week street sweeping is completed for 2020.
