Committee Reports

- 1. Public Safety Committee Mr. Dunn reported there was a meeting on July 17, attended by Ms. Gilliam, Ms. DeVincent, Chief Larrick, and Chief DeLuca. Chief Larrick had advised there was a fire truck with a radiator problem and another that the ladder needs inspected. We discussed the part-time Fire Fighter vacancy.
- 2. Mayor's Report Mayor Miller advised that her office is almost ready and thanked the Police Department, Public Works, and Fire Department for using this space. Mayor Miller also discussed the update to the Street Sweeping Schedule for ticketing purposes. Mr. Leone advised that 11th Street is signed from Duss to Lenz is ticketed, Lenz to Beaver is not to be ticketed, and Beaver to the

- Borough border is ticketed. Not sure why Lenz to Beaver is not signed for street sweeping. If the Council wants to add Lenz to Beaver to be ticketed, the ordinance will have to be amended to add that section and signage would have to be added.
- 3. Code Committee Mr. Basalyga reviewed the Code Report: Inspection Program 79 inspections conducted in July; Code sweeps 640 letters to date, 25 citations; Merchant Street Program 73 letters to date, 17 citations; Abandoned vehicles 70 letters to date, 4 citations; High Grass 500 to date, 40 citations.
- 4. Public Works Committee Mr. Cafarelli said there was no meeting this month.
- 5. Parks and Recreation Committee Ms. Gilliam advised that things are looking good in the parks in the community. They are really being utilized. Thanks to the folks in the Public Works taking care of the roads. The splash pad work is continuing. Meeting was held for Fall Festival of Churches on September 30. We've received a great response from the churches. Next meeting is August 15 at 5:45 p.m. Please feel free to come and learn what we are doing. Turtle Racing is happening this weekend and if you haven't been there, come check it out. There is a bookbag giveaway at the Park Road Pavilion this weekend. The football field is looking good and they're taking good care of it. Ms. Tessaro spoke with Mr. Galvan last week regarding the lease at Walter Panek Park. Will need to recap with him. There may not be an official signed lease. Ms. Gilliam brought up the previous request for a community-wide yard sale; spoke to the Library and they will help however they can, but they cannot facilitate it. Ms. Tessaro also spoke to Julie at the Library and they can provide flyers (waive the fee), etc. Nathan Parish and Chris Bendick were the people who originated this request.
- 6. Finance Committee
- 7. Engineer's Report Mr. Brunner advised of the issue of the parking lot at Henning Park. The contractor is insistent that the proposed inlet and storm sewer repair is adequate and will not do full reconstruction. We have an option in the contract to issue a letter. Need to give them seven days; after those seven days, we can pursue another contractor. We would take that amount off their payment per their contract. They will probably pursue remediation and potentially a lawsuit. Still a lot of unknowns in that path. Mr. Brunner's recommendation would be to do the inlet (catch basin) at no cost with the current contractor. Mr. Leone asked if they followed the specs provided. Mr. Brunner's response yes and no (described areas they complied with and those they did not comply). Mr. Cafarelli described the process they followed and described it as human error the contractor made. He feels we should pursue having contractors do it correctly. Mr. Leone/Mr. Brunner plan to prepare the letter tomorrow (Wednesday). 6th Street repairs are underway. Sink hole repair on 6th is underway. The inlet project resumed this week.
- 8. Manager's Report Mr. Leone provided the following updates:
 - O Splash pad/playground equipment arrived this week. The concrete work in the bathroom is completed so the remainder of the bathroom work can proceed. Water lines to the splashpad were installed today. Playground equipment installation will begin next week.
 - o 6th Street repairs are moving along well.
 - o Electric charging stations at the Borough Building are getting tremendous amount use.
 - Nosy air quality monitors were installed in the Borough Building collecting data on temperature and particulates in the air. Run for about a month and analyze data collected. Also has room occupancy sensor. Will provide building operation data to optimize conditions throughout the building.
 - Mr. Leone gave a presentation on the Streetscape Project. Showed Gateway signs (color format to be determined), one to be installed Merchant & 8th and the other at 11th & Merchant. Colors will probably be green and yellow with a representation of bridges. Design is still being worked on.

- o Mr. Gill asked whether a decision had been made regarding the school crossing guards. Mr. Leone advised that there has not been a final salary adjustment beyond what was decided earlier this year. We are still waiting for a response from the Ambridge School District Superintendent. There is potentially another crossing guard who might resign. Further discussion ensued.
- Mr. Gill also asked about the situation where the child was struck on Duss Avenue. Mayor
 Miller advised that she requested that Mr. Leone set up a meeting with PennDOT regarding
 multiple issues on Duss Avenue safety concerns.
- o Mr. Gill asked about posting the property for sale at 11th and Duss. Mr. Leone advised that it has not yet been advertised.
- o Glenwood Fire Properties -
- Ordinances: Stop Signs, Street Openings, Storm Water MS4, IPMC- ticketing for violations Mr. Leone advised these will be on the September Agenda.
- o Mr. Leone advised that Pittsburgh Business Times has named Ambridge one of five up-and-coming municipalities in the Pittsburgh region. Quite the accolade on the job we are doing in the Borough. There appears to be a Facebook group taking a hostile attack on the job I am doing. I don't manage the Borough based on Facebook, but based on Council's satisfaction of the job I am doing. Mayor Miller added that she appreciates the work Mr. Leone does on behalf of the Borough. Solicitor Chesney reminded Council to use caution when using social media. Mr. Cafarelli commented that the article is every elected official's dream to get coverage like this. Ambridge is the only one in Beaver County!
