**Comment** by Chief DeLuca that the resolution is needed for our accreditation process. We have to have proof that we are allowed to make these warrantless arrests as approved by Council. Solicitor Chesney added this is related to Title 42 that does not allow an officer to make a warrantless arrest for a summary offense. Once the guidelines are in place, officers will be able to make those warrantless arrests. Mr. Gill asked what the difference is, and Solicitor Chesney provided examples of warrantless arrests.

#### Committee Reports

- 1. Public Safety Committee Mr. Dunn reported that they did meet on October 18 and discussed the time for the Halloween Parade. Also discussed the ladder truck repair which is delayed until after Thanksgiving. We discussed the gun buy-back program for the Police Department. Also discussed the Civil Service issue. Ms. Tessaro recognized Fire Chief Larrick for all the hard work in getting eight firefighters training for certification. Amazing to see even volunteer firefighters putting time and effort to get this certification. Also, for providing the fire prevention at schools and day care centers. Also point out Police Chief getting us on the road to accreditation.
- 2. Mayor's Report Mayor Miller stated she attended her sixth ribbon cutting this past weekend. Some of the businesses are seeing a slow down in their business due to winter coming, so encourage everyone to share their events, etc. so we can keep those businesses open. Mayor Miller met with PennDOT on November 6 (facilitated by Rep. Matzie's office) to discuss Borough concerns. Another meeting is scheduled for November 27 regarding crosswalks and parking on sidewalk issue. PennDOT projects are scheduled out until 2027. Mr. Leone will assess some lighting concerns. Requests by the Borough can go to PennDOT for consideration. Would like a "No Turn on Red" at 4<sup>th</sup> and 65 but may require a PennDOT study.
- 3. Code Committee Mr. Basalyga presented the Code Enforcement Report. Inspection Program conducted 91 inspections this month. Code Sweeps sent out 738 letters year-to-date. Merchant

- Street Project sent 88 letters year-to-date. Abandoned Vehicles sent 80 letters year-to-date. High Grass sent 728 High Grass Letters year-to-date.
- 4. Public Works Committee Mr. Cafarelli addressed items that are in need and would like to speed things up. Need a meeting with Public Works on Friday November 17 at 9:00 a.m. on the skid steer. We will need to purchase one. There was a recent investment of \$5,000.00 and a new issue has come up with \$10,000.00 for the repair. The current equipment is a 2012 skid steer. The backhoe is used far less often than the skid steer. The skid steer is a higher priority than the backhoe. We also have to look at the budget for this. We are having an issue with our part-time employees leaving. We may want to look for a full-time position in order to retain good employees.
- 5. Parks and Recreation Committee Ms. Gilliam has not met but will have a meeting before the end of the year. Mayor Miller reminded that the rules and regulations for the parks do need to be addressed.
- 6. Engineer's Report Mr. Brunner provided an update about Henning Street Park. The contractor got the inlet installed. Fencing and sidewalks were started last week. Latches on the gates still need to be finished. Met with Columbia Gas to review their 2024-2025 projects to make sure there are no issues with our road paving projects. Started work on the cost estimates for grant submission for another road program next year. Ms. Tessaro asked about whether notification was received from Columbia Gas. Mr. Leone advised that there are three contractors working on this project for Columbia Gas. Mr. Brunner advised that we try to coordinate with Columbia Gas, but they don't provide firm dates when they will be working where. Ms. Tessaro asked about the sinkhole at 23<sup>rd</sup> and Beaver. Mr. Brunner will take a look at it. Mr. Cafarelli asked about the catch basin, what type of financial reimbursement are we going to get from the contractor. Mr. Brunner stated that there won't be any additional reimbursement beyond them doing the updated work for free. Mr. Brunner will see if there is any more he can do with the contractor.
- 7. Solicitor's Report Solicitor Chesney has some ordinances that need adopted: IPMC with the Fire Chief's changes, ordinance that repeals or revokes the Civil Service Ordinance that was passed in 2014. Change discussed earlier about the Sunshine Act. 2021 Sunshine Act was amended for government agencies, whether planning commission, civil service commission or governing body such as Council, township board of Commissioners, they can only take action on items that are on the agenda. They do allow for certain exceptions. In order to take action on any item not on the agenda, it has to follow one of the three exceptions. You have to follow the process to add an item to the agenda. Must vote to have the item added to the agenda (which can be voted down). Does not have to have public notice if it's an emergency. Mr. Gill asked if the public can still comment on something that is added to the agenda (since the public comment section is done). Solicitor Chesney advised that going forward, all items must be on the agenda for Council to act, unless it falls under one of the three exceptions.
- 8. Manager's Report Mr. Leone stated as a follow up to what Solicitor Chesney stated, you will see items on the agenda such as #5 listed as tentative, you will probably see more of the tentative items on the agenda and potentially table those items. We submitted a PennDOT Multimodal Grant for \$2.5 million targeted for the 8<sup>th</sup> Street upgrades. Grant is based on the Route 65 Corridor Study done. This comes from that finding. Today brought to the County our ARPA expenditures for reimbursement for \$1,340,761.45. We have a remaining balance of the County ARPA Funds of \$1,003,506.55. Now that Henning Park is complete, there are some remaining expenditures. We will then submit for reimbursement for the remaining funds through the DCED. Those monies will be redirected back into the Notes Capital Fund. Received a letter today from Councilwoman Beth DeVincent stating her resignation effective November 14, 2023. This resignation will be added to the next Workshop Agenda. Mayor Miller asked if we could send Councilwoman DeVincent a letter of appreciation. Mr. Gill asked about the green signs; still has the church listed as the Social Security Office. Mr. Leone stated that the "way finding" signs are under our jurisdiction. Sign at 8<sup>th</sup> and Merchant. Mr. Leone will check on that.
