We anticipate that with an enhanced maintenance program, we hope to extend the life of this piece of equipment beyond 11-12 years. Mr. Cafarelli advised that there was a meeting with Mr. Gill and Mr. Dunn for a Public Works Committee expenditure. With our trade-ins of \$58,500.00 the selling price is \$9,462.00, which is a great deal with an extended warranty of 60 months. Stressed importance of regular maintenance to extend the life of the equipment.
